

# FALCON PRIVACY POLICY

## Privacy Policy

Falcon operates falcongym.com and may operate other websites. It is Falcon policy to respect your privacy regarding any information we may collect while operating our websites.

## Website Visitors

Like most website operators, Falcon collects non-personally identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Falcon purpose in collecting non-personally identifying information is to better understand how Falcon visitors use its website. From time to time, Falcon may release non-personally identifying information in the aggregate, for example, by publishing a report on trends in the usage of its website.

Falcon also collects potentially personally identifying information such as Internet Protocol (IP) addresses for logged-in users and for users leaving comments on falcongym.com blogs/sites. Falcon only discloses logged-in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## Gathering of Personally Identifying Information

Certain visitors to Falcon websites choose to interact with Falcon in ways that require Falcon to gather personally identifying information. The amount and type of information that Falcon gathers depends on the nature of the interaction. For example, we ask visitors who sign up at [falcongym.com](http://falcongym.com) to provide a username and email address. Those who engage in transactions with Falcon are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Falcon collects such information only insofar as is necessary or appropriate to fulfil the purpose of the visitor's interaction with Falcon does not disclose personally identifying information other than as described below. and visitors can always refuse to supply personally identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## Aggregated Statistics

Falcon may collect statistics about the behaviour of visitors to its websites. Falcon may display this information publicly or provide it to others. However, Falcon does not disclose personally identifying information other than as described below.

## Protection of Certain Personally Identifying Information

Falcon discloses potentially personally identifying and personally identifying information only to those of its employees, contractors, and affiliated organisations that (i) need to know that information to process it on Falcon behalf or to provide services available at Falcon websites, and (ii) have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside of your home country; by using Falcon websites, you consent to the transfer of such information to them. Falcon will not rent or sell potentially personally identifying and personally identifying information to anyone. Other than to its employees, contractors, and affiliated organisations, as described above, Falcon discloses potentially personally identifying and personally identifying information only in response to a subpoena, court order or other governmental request, or when Falcon believes in good faith that disclosure is reasonably necessary to protect the property or rights of Falcon, third parties or the public at large. If you are a registered user of a Falcon website and have supplied your email address, Falcon may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Falcon and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it to help us clarify or respond to your request or to help us support other users. Falcon takes all measures reasonably necessary to protect against the unauthorised access, use, alteration, or destruction of potentially personally identifying and personally identifying information.

## Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Falcon uses cookies to help Falcon identify and track visitors, their usage of Falcon websites and their website access preferences. Falcon visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Falcon websites, with the drawback that certain features of Falcon websites may not function properly without the aid of cookies.

## Business Transfers

If Falcon, or substantially all its assets, were acquired, or in the unlikely event that Falcon goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Falcon may continue to use your personal information as set forth in this policy.

## Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognise your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Falcon and does not cover the use of cookies by any advertisers.

## Privacy Policy Changes

Although most changes are likely to be minor, Falcon may change its Privacy Policy from time to time, and in Falcon Gymnastics Bedford Ltd sole discretion. Falcon encourages visitors to frequently check this page for any changes to its Privacy Policy. If you have a falcongym.com account, you might also receive an alert informing you of these changes. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.
